Dear Sir,

I refer to my conversation with you of 14 days ago, and now wish to advise that the Bank has suggested that as a perpetual trophy for Dragons they submit the following suggestion to your Committee:-

- (1) Trophy to be called "The A.N.Z. Bank Trophy".
- (2) The Eank to provide a suitable honour board to be housed in an appropriate position and on which is recorded the name of the yearly winner.
- (3) The provision of a Pewter Beer Tankard (large) inscribed "The A.N.Z. Bank Trophy".
- (4) A small glass case (to be provided by the Bank) to house the tankard and to be maintained in a prominent position in the bar.
- (5) Following the announcement of the winner (presumably at the Annual meeting and/or Dinner) the recipient is required to "christen" the tankard in the accepted manner before it is returned to the custody of the bar steward.
- (6) For the entire period until the next Annual meeting/Dinner the holder is entitled to approach any member of the club and demand the tankard be filled with beer at the latter's expense. There is to be no limit to the number of members that can be approached but the one member cannot be called upon more than once daily/weekly/ monthly - your Club's Committee to decide the limitation period.

The Bank goes on to state that they have given several similar trophies to Licensed Yacht Clubs and Bowling Clubs in Victoria and such trophies have been readily accepted, however, they mention that they are
